

ORDINANCE 13-13

**AN ORDINANCE AMENDING ORDINANCE 07-12,
THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO
APPROVE NECESSARY CHANGES OF APPROPRIATIONS AND DECLARING IT AN
EMERGENCY**

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2013 on December 12, 2012; and

WHEREAS, the Council of the Village of Johnstown does hereby desire to amend its appropriations so as to address an omission of salary in the budget; and

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriation and revenues for the General Fund, Street Construction, Maintenance & Repair Fund, and Water Operations Fund be set forth in Ordinance 07-12, adopted by the Council of the Village of Johnstown, State of Ohio, on December 12, 2012, be hereby amended to read as follows:

Section Two. This Ordinance is hereby declared to be an emergency measure, the immediate passage of which is necessary for the public health, safety and welfare; wherefore, this Ordinance shall take effect and be in force immediately upon its passage.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that meetings of any of its committees that resulted in such formal action where meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code and the Charter for the VILLAGE OF JOHNSTOWN.
