ORDINANCE 01-2014

AN ORDINANCE AMENDING ORDINANCE 07-12, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS AND DECLARING IT AN EMERGENCY

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2013 on December 12, 2012; and

WHEREAS, the Council of the Village of Johnstown does hereby desire to amend its appropriations so as to address an omission of salary in the budget; and

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriation and revenues for the General Fund, Street Construction, Maintenance & Repair Fund, and Water Operations Fund be set forth in Ordinance 07-12, adopted by the Council of the Village of Johnstown, State of Ohio, on December 12, 2012, be hereby amended to read as follows:
