ORDINANCE 09-2014

AN ORDINANCE AMENDING ORDINANCE 15-13, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS AND DECLARING IT AN EMERGENCY

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2014 on December 10, 2013; and

WHEREAS, the Council of the Village of Johnstown does hereby desire to amend its appropriations; and

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriation and revenues for the General Fund, Street Construction, Maintenance & Repair Fund, and Water Operations Fund be set forth in Ordinance 15-13, adopted by the Council of the Village of Johnstown, State of Ohio, on December 10, 2013, and amended in Ordinance 02-14 on April 15, 2014, be hereby amended to read as follows:

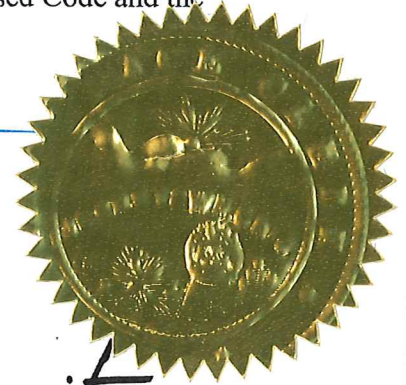
