**Exhibit "C"** Applicant shall provide a Village approved traffic control plan consistent with the requirements of Section 931.13(B)(2)(d) and The Ohio Manual of Uniform Traffic Control Devices); (Labeled Exhibit "C").

**Exhibit "D"** Pursuant to Section 931.13(B)(2)(e), if Applicant is proposing to install an above ground installation on existing poles within the Rights of Way, the Applicant shall provide credible information satisfactory to the Village to sufficiently detail and identify the size and height of the existing poles and when and if requested by the Village Engineer, the current excess capacity on such existing poles before Applicant's installation and the excess capacity for like or similar facilities on such existing poles after Applicant's installation; (Labeled Exhibit "D").

**Exhibit "E"** Pursuant to Section 931.13(B)(2)(f), if Applicant is proposing to install new poles within the Rights of Way, the Applicant shall provide, the location, size, color, material of the proposed poles and credible evidence satisfactory to Village that: no excess capacity exists on current poles; or in existing underground systems that it is not financially and/or technologically practicable to make an underground installation or locate facilities on existing poles; that Applicant will adhere to all applicable Laws concerning the installation of new poles; (Labeled Exhibit "E").

**Exhibit "F"** Pursuant to Section 931.13(B)(2)(g), if Applicant is proposing an underground installation in existing ducts or conduits within the Rights of Way, the Applicant shall provide credible information satisfactory to the Village to sufficiently detail and identify, based on existing facilities: the excess capacity for like or similar facilities in such ducts or conduits before the installation of Applicant's Facilities; the excess capacity for like or similar facilities in such ducts or conduits after the installation of Applicant's Facilities; (Labeled Exhibit "F").

**Exhibit "G"** Pursuant to Section 931.13(B)(2)(h), if Applicant is proposing an underground installation within new ducts or conduits within the Rights of Way, the Applicant shall provide credible information satisfactory to the Village to sufficiently detail and identify: the location, depth, size and quantity of new ducts or conduits and; the excess capacity for like or similar equipment that will exist in such ducts or conduits after the installation of Applicant's Facilities; (Labeled Exhibit "G").

**Exhibit "H"** Pursuant to Section 931.13(B)(2)(i), Applicant shall provide: a preliminary construction schedule and completion date; (Labeled Exhibit "H").

**Exhibit "I"** Pursuant to Section 931.13(B)(2)(j), Applicant shall provide payment of: all money due the Village for Permit Fees; and any loss, damage, or expense suffered by the Village as a result of Applicant's prior Construction in the Village Rights of Way or any Emergency action taken by the Village; any Certificate of Registration issued to Applicant or Person for whom Facilities are being Constructed; any other money due the Village from Applicant or Person for whom Facilities are being Constructed; (Labeled Exhibit "I").

\_\_\_\_\_ **Exhibit "J"** Pursuant to Section 931.13(B)(2)(k), when a Construction Permit is requested for purposes of installing additional Systems or any part of a System, the posting of a Construction Bond and Removal Bond in accordance with Chapter 931.17 and acceptable to the Village may be required; (Labeled Exhibit "J").
