## ORDINANCE 26-2015

### AN ORDINANCE AMENDING ORDINANCE 11-14, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS

**WHEREAS**, the Council of the Village of Johnstown adopted its annual appropriations for 2015 on December 19, 2014; and

**WHEREAS**, the Council of the Village of Johnstown does hereby desire to amend its appropriations so as to address additional expenses; and

**NOW THEREFORE**, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

**Section One.** That the appropriation and revenues for the General Fund, Water and Sewer Operation Funds, and Street Construction maintenance and Repair Fund set forth in Ordinance 11-14, adopted by the Council of the Village of Johnstown, State of Ohio, on December 19, 2014, be hereby amended to read as follows:
