ORDINANCE 04 - 2016

AN ORDINANCE AMENDING CERTAIN SECTIONS OF THE CODIFIED ORDINANCES OF THE VILLAGE OF JOHNSTOWN, OHIO IN ORDER TO SET WATER SERVICE RATES, CHARGED BY THE VILLAGE OF JOHNSTOWN

WHEREAS, the Village Manager, Finance Director and Service Director have reviewed the utilities service rates charged by the Village of Johnstown and the associated fund balances, and have recommended an amendment to the allocation of established fees; and

WHEREAS, the Council of the Village of Johnstown desires to amend the rate allocation structure to properly provide for operations of the Water and Sewer Divisions of the Service Department.

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio as follows:

Section 1. That Section 921.05, "Rates", is hereby amended as follows:

(a) The water service rates to be charged for water service provided to property located within the Village shall be as follows:

(b) The water service rates to be charged for water service provided to properties outside of the Village limits shall be the above rates plus a surcharge of one-hundred percent (100%) of such rates unless otherwise determined by the Manager through a developers agreement.

Section 2. Any ordinance or portion thereof in conflict with the provisions of this ordinance is hereby repealed.

Section 3. The effective date of the rate structure shall be April 1, 2016




