ORDINANCE 26-2016

AN ORDINANCE AMENDING ORDINANCE 25-15, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS AND DECLARING IT AN EMERGENCY

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2016 on December 15, 2015; and

WHEREAS, the Council of the Village of Johnstown does hereby desire to amend its appropriations; and

WHEREAS, the net effect on the finances of the Village of Johnstown will be \$0; and
