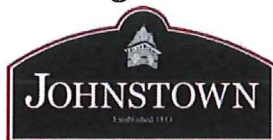

ORDINANCE 41-2016

AN ORDINANCE AMENDING ORDINANCE 25-15, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2016 on December 15, 2015; and

WHEREAS, the Council of the Village of Johnstown does hereby desire to amend its appropriations to cover a projected negative 2016 fiscal year ending balance in the General Fund.

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriation for the General and Budget Stabilization Funds that were set forth in Ordinance 25-15, adopted by the Council of the Village of Johnstown, State of Ohio, on December 15, 2015, be hereby amended to read as follows:




