ORDINANCE 32-2017

AN ORDINANCE AMENDING ORDINANCE 42-16, THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO APPROVE NECESSARY CHANGES OF APPROPRIATIONS

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2017 on December 6, 2016; and

WHEREAS, the Village of Johnstown has incurred some unexpected costs in 2017 that are necessary to provide for the ongoing daily operations of the Village; and,

WHEREAS, these unexpected costs cannot be sustained by the appropriations that were approved and adopted in the 2017 annual budget and are listed below:

1. Travel & Transportation - \$1,200.00. To pay for gas and other travel-related expenses for the remainder of 2017 for the Village Manager.
2. Generator Maintenance - \$1,200.00. To pay for necessary maintenance on the backup power generator that supports the Village administration building & Police Department.
3. Police Cruiser engine replacement - \$6,600.00. To pay for the engine replacement on the 2011 Ford Explorer.

WHEREAS, the General fund balance is sufficient to cover these necessary expenditures.

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriations for the General Fund that were set forth in Ordinance 42-16, adopted by the Council of the Village of Johnstown, State of Ohio, on December 6, 2016, be hereby amended to read as follows:

1000-730-543200	Maintenance of Equipment and Facilities	(increase)	\$ 1,200.00
1000-110-543100	Repairs & Maintenance – Cruisers	(increase)	\$ 6,600.00

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that meetings of any of its committees that resulted in such formal action where meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code and the Charter for the VILLAGE OF JOHNSTOWN.
