



ORDINANCE 52-2017

**AN ORDINANCE AMENDING ORDINANCE 42-16,
THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO
APPROVE NECESSARY CHANGES OF APPROPRIATIONS AND DECLARING AN
EMERGENCY**

WHEREAS, the Council of the Village of Johnstown adopted its annual appropriations for 2017 on December 6, 2016; and

WHEREAS, the Ohio Public Works Commission has agreed to assist the Village of Johnstown with the cost of replacing a storm sewer at the intersection of North Oregon Street & Edwards Road in the form of a Grant/Loan Agreement; and

WHEREAS, the Edwards/Oregon Storm Sewer Replacement project, which commenced in October 2017, has exposed a crushed storm sewer which lies adjacent to the storm sewer being replaced within the Edwards/Oregon Storm Sewer Replacement project; this adjacent storm sewer also needs to be replaced to achieve successful water drainage from the project area; and

WHEREAS, the net effect on the finances of the Village of Johnstown will be an increased appropriation of \$10,500.00.

WHEREAS, the Capital Improvements Fund balance is sufficient to cover this appropriation; and

WHEREAS, the circumstances require this Ordinance to be adopted as an emergency measure.

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

Section One. That the appropriations for the Capital Improvements Fund that were set forth in Ordinance 42-16, adopted by the Council of the Village of Johnstown, State of Ohio, on December 6, 2016, be hereby amended to read as follows:

Section Two. This ordinance is hereby declared an emergency measure necessary for the immediate preservation of the public health, safety, and welfare in that the Village budget is based on the anticipated receipt of this revenue and shall be in full force and effect at the earliest date provided by law.


Section Three. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that
