RESOLUTION 2017-05

A RESOLUTION TO APPOINT COUNCIL COMMITTEE MEMBERS

Whereas, Section 7.01 of the Charter of the Village of Johnstown authorizes committees created by Council and Resolution 2016-07 established staggered two year terms for the Committees of Council; and

Whereas, Section 7.02 (h) of the Charter of the Village of Johnstown says that no member of any committee shall serve on the same committee for more than two consecutive full terms.....; and

Whereas, Section 7.04 (a) of the Charter of the Village of Johnstown states that the Personnel Board of Review shall consist of three electors of the Municipality who shall serve overlapping three-year terms.

Whereas, the Village Council desires to appoint Council representatives to the expiring terms of the Council committees and the Personnel Board of Review; and

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Johnstown, Licking County, Ohio as follows:

Section One: The Village Council herein approves the following committee term appointments:

Economic Development Committee: Economic Development Committee's purpose is to foster the retention and expansion of existing business and industry, as well as the attraction of new business and industry by encouraging responsible, economic development activities that result in job creation, retention, diversifying the community's tax base and an improved sustainability and quality of life for the citizens of the Village.

1. Carol Van Deest Term - January 1, 2016 and ending on December 31, 2017 (First term)
2. Cheryl Robertson Term - January 1, 2016 and ending on December 31, 2017 (First term)
3. Sean Stanearth Term - January 1, 2017 and ending on December 31, 2018 (Second term)
(Expired term was a partial second; Sean Stanearth 1/1/2016 -12/31/2016)

Finance Committee: The Finance Committee shall consider matters relating to the finances and the various funds of the Village, the development of the annual budget of the Village, the authorization of expenditures, the consideration of requests for funding, the payment of personal services and claims, and the authorization of the transfer of money from one established account to another within departments of the Village.

2. Lewis Main Term - January 1, 2016 and ending on December 31, 2017 (First term)
3. Ben Lee Term - January 1, 2017 and ending on December 31, 2018 (First term)

Rules Committee: The Rules Committee shall consider amendments to the Council Rules and questions of interpretation of the existing Rules. It shall also handle questions of appointment of special Committees of Council and the appointment of Council members to bodies requesting Council representation.

2. Sharon Hendren Term - January 1, 2016 and ending on December 31, 2017 (First term)
3. Sean Stanearth Term - January 1, 2017 and ending on December 31, 2018 (First term)

Safety & Service Committee: The Safety and Service Committee meets to review service matters that include items for the Water, Wastewater, Street, and Police Department.

2. Ben Lee Term - January 1, 2016 and ending on December 31, 2017 (First term)
3. Sharon Hendren Term - January 1, 2017 and ending on December 31, 2018 (Second term)
(Expired term was a partial second; Sharon Hendren 1/1/2016 – 12/31/2016)

School District Liaison Committee: The School District Liaison Committee meets to enable officials of the Village Government and School Board to confer on a regular basis to achieve community financial coordination and better coordination in other fields of community concern. Meeting time is the first Tuesday of each month at 5:00 p.m. at the Village office.

Johnstown Park and Recreation Committee: The Johnstown Park and Recreation Committee meets to discuss relating to the development of parks and to plan for the provision of certain education, recreation, leisure and cultural development for the residents of Johnstown, the Village Council should create a committee to advise the Village Council on such matters.

2. Sharon Hendren Term - January 1, 2016 and ending on December 31, 2017 (First Term)
3. Bill Van Gundy Term - January 1, 2017 and ending on December 31, 2018 (First Term)
(Expired term was a partial first; Carol Van Deest 1/1/2016 – 12/31/2016; moved to Lee's unexpired term)


Personnel Board of Review Board: The Personnel Board of Review shall have the power and duty to hear appeals from administrative determinations made pursuant to the Code of Personnel Practices and Procedures, and such other powers, duties and functions as provided by Council. The judgment of the Personnel Board of Review, for the purposes of the Municipality, shall be final.

1. Sean Stanearth: Term - January 1, 2016 and ending on December 31, 2017 (First term)
2. Cheryl Robertson: Term - January 1, 2016 and ending on December 31, 2018 (First term)
3. Bill Van Gundy Term - January 1, 2017 and ending on December 31, 2019 (Second term)
(Expired term was a partial second; Bill Van Gundy 1/1/2016 – 12/31/2016)


