



ORDINANCE 11-2018

AN ORDINANCE AMENDING CERTAIN SECTIONS OF THE CODIFIED ORDINANCES OF THE VILLAGE OF JOHNSTOWN, OHIO IN ORDER TO SET WATER DEBT SERVICE RATES, CHARGED BY THE VILLAGE OF JOHNSTOWN

WHEREAS, the Village Manager, Finance Director and Service Director have reviewed the utilities service rates charged by the Village of Johnstown and the associated fund balances, and have recommended an amendment to the allocation of established fees; and

WHEREAS, the Council of the Village of Johnstown desires to amend the rate allocation structure to properly provide for operations of the Water and Sewer Divisions of the Service Department.

NOW THEREFORE, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio as follows:

Section 1. That Section 921.17, “Debt Service Fee”, is hereby amended as follows:

The water debt service fee to be charged in conjunction with water service provided to property owners located within the Village shall be as follows:

2018 USAGE	WATER DEBT SERVICE CHARGE
0-2000 Gallons per Month	\$3.10 Minimum per Month
2001 Gallons and above per Month	\$1.63 per Thousand Gallons per Month
2019 USAGE	WATER DEBT SERVICE CHARGE
0-2000 Gallons per Month	\$3.10 Minimum per Month
2001 Gallons and above per Month	\$1.63 per Thousand Gallons per Month
2020 USAGE	WATER DEBT SERVICE CHARGE
0-2000 Gallons per Month	\$3.10 Minimum per Month
2001 Gallons and above per Month	\$1.63 per Thousand Gallons per Month

Section 2. Any ordinance or portion thereof in conflict with the provisions of this ordinance is hereby repealed.

Section 3. The effective date of this Ordinance, which sets the new rate structure, shall be the first day of the reading cycle following passage of this Ordinance on or about May 17, 2018, to begin allocation with the July 2018 billing.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that meetings of any of its committees that resulted in such formal action were meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code and the Charter for the VILLAGE OF JOHNSTOWN.
