



**ORDINANCE 22-2018**

**AN ORDINANCE AMENDING ORDINANCE 57-2017,  
THE ANNUAL APPROPRIATION ORDINANCE OF THE VILLAGE OF JOHNSTOWN TO  
APPROVE NECESSARY CHANGES OF APPROPRIATIONS**

**WHEREAS**, the Council of the Village of Johnstown adopted its annual appropriations for 2018 on December 5, 2017; and

**WHEREAS**, the Council of the Village of Johnstown wishes to grant a merit increase to all Service Department employees effective on their respective anniversary dates; and

**WHEREAS**, the Council of the Village of Johnstown wishes to hire a seasonal part-time employee to assist the Street Department, and;

**WHEREAS**, the net effect on the finances of the Village of Johnstown will be an increased appropriation of \$13,000.00; and

**WHEREAS**, the Fund balances for the Funds listed in Section One below are sufficient to cover this appropriation; and

**NOW THEREFORE**, be it ordained by the Council of the VILLAGE OF JOHNSTOWN, Licking County, Ohio, as follows:

**Section One.** That the appropriations for the General, Street Construction, Maintenance, & Repair, Water Operating, and Sewer Operating Funds that were set forth in Ordinance 57-2017, adopted by the Council of the Village of Johnstown, State of Ohio, on December 5, 2017, be hereby amended to read as follows:
